On January 6, 2022, over 50 members of the general aviation community were present for the first inaugural meeting of the Hartford Brainard Airport Association (HBAA). Represented were general aviation pilots, flight instructors, student pilots, business leaders, avionics and aircraft maintenance business owners, and a wide array of community leaders representing central Connecticut. Everyone present was there to learn about the renewed efforts by both city of Hartford and Connecticut State politicians to close this busy and very active facility that has been serving the region for over 101 years. the agenda for this meeting was education – to - and then strategy development - to determine what actions must be taken to halt this remarkably poor decision by Hartford City Council to close a important re-

gional asset. The very enthusiastic 3 hour meetlearn what was happening ing concluded with a dedicated call to action and the creation of a formal, organized and professional movement committed to keeping this valuable facility from permanent closure.

Executive Committee Formed

Hartford Brainard Airport Association will be formally organized as a not-forprofit 501 (c)(3) Corporation with legal representation from the Brown, Pandaris & Scott law firm. A seven-member executive

board has also been organized and is charged with the task of investigating all opportunities to both promote the benefits of general aviation and seek legal options, if necessary, to persuade the City against seeking closure.

Educating the general public as to the reasons why Brainard should stay open is a primary focus. The Board welcomes any participation from interested parties who wish to promote the future of general aviation in Hartford.

President Biden Visits Hartford

On October 15, 2021, President Joseph Biden visited Connecticut to promote his "Build Back Better" agenda and visit our Capitol city. Air Force 1 landed at Bradley Airport, but to avoid the 18 mile, 35 minute drive, the President chose to helicopter and land at



Located at Brainard Field, Hartford

As a part of the Connecticut Technical Education and Career System, CT Aero Tech offers exceptional training programs for adult learners in the Aviation Maintenance Technology Fields. The school is an approved Aircraft Maintenance Technician School by the FAA under CFR 14 part 147. The CT Aero Tech School offers exemplary instruction and preparation for certification as Airframe and Power-Plant Technicians. The twenty-month program is designed to provide hands-on training where students learn metalwork, woodwork, welding, hydraulics, electrical, painting, and engine-overhaul among other skills. CT Aero's graduates are able to interpret FAA regulations and manufacturer's technical

specifications. The school's mission is to provide the opportunities, expert instruction, and guidance to ensure their students accomplish their goals. Upon completing the General, Airframe and Power Plant curriculums, students are eligible for certification as mechanics with Airframe and or Power Plant ratings. They are prepared to take FAA examinations.

A national shortage of aviation mechanics exists now and threatens the projected expansion and modernization of the global airline fleet in both commercial and general aviation.

The training program at CT Aero Tech at Brainard Airport is critically necessary to support the aviation industry.
